

There's More Ministries Courtroom Video Training and Personal Activations

Notes - Session 6, Oct. 18th, 2020

GOAL: To discover the kingdom purpose, original Intent from the books of Heaven what God says about a person, place or situation? Original design or Intent. (VIA Scriptures, Prophetic Words, Visions, and Passions). To learn the protocols of presenting a petition. To understand the depth of our authority and what speaks on our behalf in the courts. To understand whose voices speak in court. **The practical aspects of the courts and define our legal rights.**

Accuser of the brethren. Breakthrough comes when silencing the argument against you from a demon, it's not a demon on a battlefield, it's an argument against you in spirit realm. They overcame him by the blood of the lamb, their testimony, and not loving their lives unto the death.

Walk in the light, fellowship, it keeps on cleansing us... the blood keeps speaking only when we walk in the light as He is in the light. Repentance is walking out of darkness into the light.

Five things you need to present your case in court.

- 1) You must present a case based on your prophetic purpose on the books of heaven. The purpose God gave you that is written in your book. (This is what you said, believe, what I was made for, and you will allow me the right to do this and it would become reality, whatever you have heard from the Lord and grace on you, that your name will be exalted). Not called because of what you can do. Whatever your purpose is there is grace attached to it. How do we know if it is our purpose/graced to do? (God may have to change your heart, he works in you to do his will and good pleasure).
 - a. Enjoy it.
 - b. You will have gifts to do it with on a significant level.
 - c. Grace will make you a success in what you do, there will be fruitfulness.
 - d. Whatever you're graced to do, you will be able to make money doing it.
 - e. Another sign, the right people will bear witness to. Focus on the ones whose hearts been touched with you. That will help you launch.
- 2) Take the prophetic words prophesied over you and use that to present a case in heaven. Lord, your prophet _____, he said this about me. I bring those words to you Lord, I am asking you to allow this to happen. I am asking for a decision to be made, to let what was prophesied to become a reality.
- 3) Use what Jesus did for you, Lord, I remind the courts of what Jesus did for me. I remind the courts I have a right to this breakthrough, I bring what He has done as evidence, what He has done I say it is

speaking on my behalf as evidence, and the breakthrough I am contending for become a reality. The body and the blood of Jesus is speaking on behalf of this person, on the basis of that testimony be on behalf of that person.

- 4) Use of the promises of God's Word as evidence.
- 5) Present an offering, tithes and offerings, (an act of worship) your offering has a sound attached to it in heaven. Whatever the state of your heart is when you bring an offering that is what is attached to it in the heavens. Agree with your adversary quickly before he brings you before the judge and thrown into prison. Pray for silence of wrong offering. Job example. Pray for your offerings to be a voice of breakthrough speaking on your behalf.

	Don't open your only iniquity will visit a person to 3 and 4 generations God has set a statue of limitations. Illegitimate birth goes to 10 th . When you pray that way you make it admissible in court.
	Don't get caught up in endless genealogies you can never get finished.
	The blood dismisses cases against us. In court you have to refute what's against us.
	To get a breakthrough you must be able to present a case. I understand the verdict you want, you
	have to give me evidence to find in your favor. It's not good enough that your passionate, good heart,
	or feel a burden, or that I think you're right. You must give me evidence to let me give you the verdict

How To Present Your Case (Make a Case) Jesus is your mediator, Holy Spirit is your counsel, and God is Judge. Remember this is not a formula! Just a railroad track to jump off and allow the Spirit to guide you.

- 1. Be aware of proper Protocol for where you are (True in every ministry setting.)
- 2. Present yourself as a sacrifice and repent and ask for the Blood to cover you.
- 3. Get Into Spiritual Atmospheric realm, ask Jesus to come to where He is. (He inhabits our Praise)
- 4. Worship opens books in heaven.
- 5. Do not present a need

you want.

- 6. Do not present your ideas
- 7. Present your case on what's in your book based on your prophetic purpose!
- 8. Present a purpose from your book, discern your book. (You have prophetically discerned over you, your family, nation.)
- 9. Present what is written about you, your family member, nation
- 10. Ask for the books to be opened and court to be in session
- 11. Pay attention to the unction of the Holy Spirit

- 12. By faith, open the eyes of your heart (imagination) for spiritual activation and believe you are standing in the courtroom or counsel room. Ask Jesus to bring you to Him or Him to come near to you.
- 13. Ask for Counsel, is there anything we should know before we enter into the court?
- 14. The blood dismisses cases.
- 15. The word of our testimony, we use to present our cases.
- 16. All issues have to be presented!
- 17. Call on your history of sowing into heaven.
- 18. I call all prophetic words to come into rememberance.
- 19. Call on the promises of God's Word
- 20. Come into the courts and agree with what is already happening in the courts.
- 21. We can stand in the gap for a person, nation, culture, tribe.
- 22. Ask for the legal rights of the enemy to be revoked.
- 23. Ask for a divorce of all previous claims on us.
- 24. Ask for a divorce for demonic that is hindering and harassing you.
- 25. We can petition the court records of our sacrifices.
- 26. We can petition the court to let our Tithe's and Offerings release a testimony on our behalf (because it has a voice). Make sure your motives are purified, you're giving an offering of righteousness, so the witness is in your favor.
- 27. Silence the tongue of the accuser. Righteous one has the right to condemn their tongues.
- 28. Thanksgiving is a key, thank the Lord for speaking on your behalf.
- 29. You have to have evidence in the mouth of 2-3 witnesses to have a verdict rendered.
- 30. Agree with the spirit of the witness in the courts.
- 31. Agree with Jesus intercessory prayer, this brings unity in the spirit of testimony to render verdicts.
- 32. Prophets can't prophecy unless they are open. Whatever is resisting your purpose, ask the court for a judgment against that which is fighting. (Make sure you have repented, and it's the enemy fighting you, and not you resisting God)
- 33. Ask the Lord to judge everything that is fighting against your will, a person, situation etc.
- 34. Angels are the ones who carry out the verdicts: Zech 5 example.
- 35. Call it back to remembrance- Release a genuine faith, it keeps you believing the impossible. Call things that are not as though they are.
- 36. Genuine faith says I will not be denied justice.
- 37. Faith requires action. What action do you need to do for this courtroom?
- 38. Don't give the enemy a right that God didn't give him; only go back to the 4 generations. We enact your statute of limitations and nothing past that is admissible in the court settings. Court only functions on the evidence that is allowed in. NO more than four generations is admissible. Don't give the devil access to drag into the courts other issues before them, that you don't have time or ability to see that far back. Don't deal with endless genealogies in the courts.
- 39. Receive a verdict (scroll, writing, gavel, specific words, or vision).
- 40. Ask for all to be recorded in the books of all those associated. Case closed.
